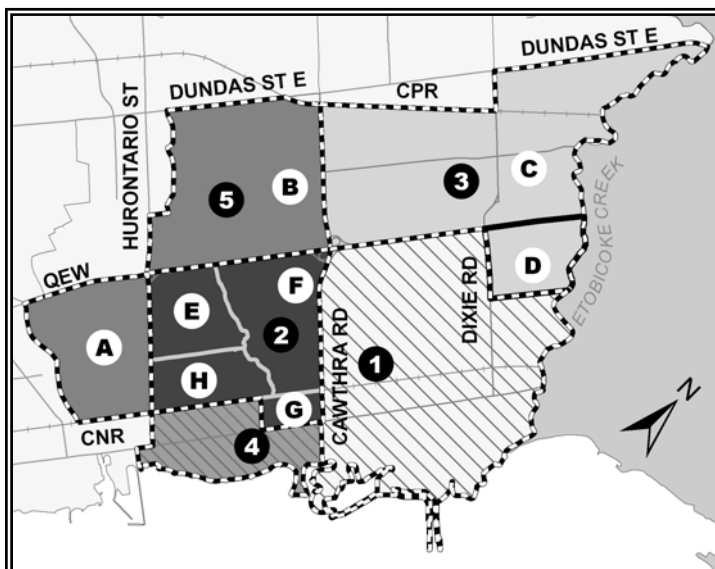

### **Where can I find information about the Accommodation Review Process?**

The information includes Ministry of Education Guidelines, the Board process, Accommodation Review Committee (ARC) meeting agendas and minutes, copies of the School Valuation Framework, accommodation options and related maps.

### **When will a decision be made and how will I be notified?**

The Board of Trustees will make a decision at a Public Meeting at the Board’s Office in Fall 2008. The Board will make their decision after reviewing the recommendations outlined in the reports submitted by the ARC and the Board’s Planning Department.

The meeting of the Board of Trustees will be advertised in local newspapers and on the Board’s website sixty (60) days prior to the meeting date. Once a decision has been made notices will be delivered to all affected schools and students, adjoining residents, and in local newspapers.

### **When will my school be closed?**

A closure date has not been determined. The closure date will be established through the recommendation reports submitted by the ARC and the Planning Department, a final decision will be made by the Board of Trustees. An anticipated closing date is at the end of the 2008/2009 school year.

### **If our school closes, will my child be bussed?**

Transportation for students is based on age and distance to the school, the current Board transportation distances are set out in the adjoining chart.

Transportation Distances	
Kindergarten:	1 km
Grades 1-4:	1.6 km
Grades 5-6:	2 km
Grades 7-8:	3.2 km
Grades 9-12:	4.8 km

### **What will happen to our school site if it is closed?**

The Board has made no decision regarding the future use/disposition of the school site and building. The Board must follow the Ministry of Education regulations. This will occur once a decision has been made to close a school.
