NOTICE OF PUBLIC MEETING

This letter is to advise the public that the Dufferin-Peel Catholic District School Board will be convening a first public meeting for the Pupil Accommodation Review process. This is a process which undertakes the necessary steps to enable the Board to determine whether it should close schools in the future. The process is in accordance with the Dufferin-Peel Catholic District School Board Pupil Accommodation Review Regulation and complies with the Ministry of Education Pupil Accommodation Review Guidelines.

The Board's Planning Department has undertaken an analysis of capacity and enrolment for all elementary and secondary schools in Dufferin-Peel. The **Bramalea North** Accommodation Review Area consisting of **Mother Mary Ward, St. Anthony, St. Marguerite Bourgeoys and Lester B. Pearson** elementary schools has been identified as an area with enrolments below 250 students, enrolments lower than 50% of capacity and/or an area experiencing an overall declining enrolment.

An Accommodation Review Committee has been established to compile and consider data and options for each school in the Accommodation Review Area. Schools in the Accommodation Review Areas may be considered for one or more of the following: consolidation and/or closure; as a receiving school; reorganization by way of a boundary adjustment or redirection of specialty programs; or simply be included in the geographical area.

The Accommodation Review Committee, made up of Board staff, school principals, school council chairpersons, teacher representatives, and parish representatives will be considering long term accommodation options and will also be conducting a public consultation process to obtain input from the local community. In this regard, the Accommodation Review Committee will be convening four public meetings to provide the public with an opportunity to ask questions, obtain additional information and express their comments on matters.

This first public meeting has been scheduled as follows:



Further information on the Dufferin-Peel Catholic District School Board Pupil Accommodation Review Policy, Regulation and School Valuation Framework and the Ministry of Education Pupil Accommodation Review guidelines are also posted on the Board's website.

The chart below provides an outline of the process to be undertaken in conjunction with the Pupil Accommodation Review process and a preliminary timeline. It should be noted that considerable time

is allocated in the process for securing public input prior to any decisions being adopted by the Board of Trustees. Please further note that your Area Trustee is not a member on the Accommodation Review Committee which is currently conducting the initial phase of the review process which is an information collection and analyses stage. In the Fall of 2008, all of the data and community input collected by the Accommodation Review Committee, the Committee recommendations as well as staff analyses, will be submitted to the Board of Trustees for consideration. The Board of Trustees will conduct further public meetings to secure input from the community prior to making decisions. You will receive notice of these meetings.
