



## NOTICE OF PUBLIC MEETING

This letter is to advise the public that the Dufferin-Peel Catholic District School Board will be convening a fourth public meeting for the Pupil Accommodation Review process. This will be the final public meeting by the Accommodation Review Committee: after taking into consideration the comments, questions and concerns of the community, the Committee will be presenting their preferred consolidation option(s). Following this meeting, the Committee will prepare a report and present their findings to the Board of Trustees who will make a decision at a Public Meeting in Fall 2008. The process is in accordance with the Dufferin-Peel Catholic District School Board Pupil Accommodation Review Regulation and complies with the Ministry of Education Pupil Accommodation Review Guidelines.

The Board's Planning Department has undertaken an analysis of capacity and enrolment for all elementary and secondary schools in Dufferin-Peel. The **Central Erin Mills** Accommodation Review Area consisting of **Blessed Trinity, Divine Mercy, Our Lady of Mercy, St. Joseph and St. Rose of Lima** elementary schools has been identified as an area with enrolments below 250 students, enrolments lower than 50% of capacity and/or an area experiencing an overall declining enrolment.

The Accommodation Review Committee has been established to compile and consider data and options for each school in the Accommodation Review Area. Schools in the Accommodation Review Areas may be considered for one or more of the following: consolidation and/or closure; as a receiving school; reorganization by way of a boundary adjustment or redirection of specialty programs; or simply be included in the geographical area.

Further information on the Dufferin-Peel Catholic District School Board Pupil Accommodation Review Policy, Regulation and School Valuation Framework and the Ministry of Education Pupil Accommodation Review guidelines are also posted on the Board's website.

It should be noted that considerable time is allocated in the Pupil Accommodation Review process for securing public input prior to any decisions being adopted by the Board of Trustees. Please further note that your Area Trustee is not a member on the Accommodation Review Committee which is currently conducting the initial phase of the review process which is an information collection and analyses stage. As noted above, the Accommodation Review Committee will conduct four public meetings. Subsequent to the completion of the public meetings, all of the data and community input collected by the Accommodation Review Committee, the Committee recommendations as well as staff analyses, will be submitted to the Board of Trustees for consideration. The Board of Trustees will conduct further public meetings to secure input from the community prior to making decisions. You will receive notice of these meetings.
