May 1 - Memorial of St. Joseph the Worker – International Workers’ Day is celebrated in many countries to recognize the value of human work, defend the dignity of working people, encourage all to be responsible in their work, and celebrate the role that human work has in God’s plan for creation. Our board observes May 1 as DPCDSB Staff Appreciation Day. We express gratitude to our staff for the important work they do in publicly funded Catholic education, in service to the children and youth entrusted to our care.

Mental Health Week 2024 – May 6-10 is Mental Health Week. During this week, all students are invited to participate in a selection of wellness activities and resources provided by the DPCDSB Well-Being Department, which can be embedded in everyday lessons. At the local school level, one day of this week can be designated as a wellness day, the focus of which is “Wellness for Success”. It provides an opportunity for students to ‘pause’ and focus on catching up, reviewing, and resetting goals.

Shining Stars Special Olympic Event – This year marks the 13th Anniversary of The Shining Stars Special Olympic Event and will be hosted by our Mississauga North Family of Schools on Thursday May 9 at St. Aloysius Gonzaga Catholic Secondary School. Intermediate volunteers from various schools will also help lead the student activities.

Student Transportation Update and Service Delivery

- **Driver Status** - Student Transportation of Peel Region (STOPR) continues to monitor all contracted bus operators through monthly reporting to ensure they have an adequate number of drivers and spare drivers to operate all routes. Currently, bus operators are reporting that they have enough drivers to service all routes.
- **Chipmunk Parent Application** - Testing of the Chipmunk parent application continues at selected pilot schools. Regular meetings between STOPR staff and the vendor continue through the testing process before assessing the readiness of proceeding with a full system launch.
- **School Bus Safety Training** - For the 2023-2024 school year, 64 DPCDSB schools were identified to receive school bus safety training. As of March 2024, school bus safety sessions have been presented at 58 DPCDSB schools. The remaining schools will receive safety sessions prior to the end of this school year. Schools that did not receive school bus safety training this year were offered standard school bus evacuation training. School bus evacuation training can be provided through an online video link or presented at each school in-person by our local school bus operators.
- **First Time Rider Program 2024** - STOPR has confirmed it will host the next *First Time Rider Safety Program* on Saturday August 24. A “save the date” memo and flyer was distributed to all elementary schools in January and a reminder will be included in STOPR’s upcoming Spring Newsletter.

Long-Term Facilities Master Plan (LTFMP) - DPCDSB currently operates regular day school programs at 151 schools (125 elementary and 26 secondary). Schools range in age from four years old to approximately 70 years old. Over 70% of the current school inventory (106 schools) was constructed since the 1980s, with the largest grouping of these schools (46) being constructed between 1996 and 2005.

DPCDSB continued to experience enrolment decline from the 2022-2023 to 2023-2024 school year. An enrolment decline of over 983 students (-1,100 elementary and +117 secondary students) over this 12-month period has been attributed to many factors, including admission and demission of students year over year, families emigrating from the jurisdiction of DPCDSB and the changing demographics in Peel Region. Over the next ten years, our board is expected to experience a net enrolment decline of approximately -4.82% (-3,442 total students), which is comprised of a projected decline in the elementary panel of approximately -5.45% (-2,257 elementary students) and a projected decline in the secondary panel of -3.95% (-1,185 secondary students). While overall, DPCDSB shows enrolment decline, it is important to note that there are still areas within the board that are experiencing enrolment growth. The LTFMP reflects the enrolment changes through various recommendations for consideration, such as adding new pupil places either through new schools or

additions to schools, through business case requests submitted to the Ministry of Education for funding consideration, and balancing enrolment through the realignment of school boundaries, program changes and pupil accommodation reviews (PAR). The Ministry of Education continues its moratorium on PAR. More information is included in our Board of Trustees - Administration and Finance Committee's April 9, 2024 Meeting Agenda located on the DPCDSB website.

Energy Management Plan - Energy management is an integrated part of DPCDSB's LTFMP to support ongoing instructional services and facility operations. Energy conservation not only contributes to long-term sustainability, it also plays an important role in containing the total cost of utilities to DPCDSB. The performance review for the past five years from 2018 to 2023 revealed a significant cumulative energy reduction and containment of costs by DPCDSB as a result of a concerted system-wide effort to manage energy demand.

The pandemic in early 2020 significantly changed how schools operated and impacted their energy consumption. While consumption of utilities initially fell in 2020 during a time when schools were closed, consumption levels increased once schools re-opened due to a list of substantial operational changes, including:

- increased ventilation (intake of fresh air)
- increased filtration requirements (*MERV-13 filter)
- expanded operating hours of HVAC equipment (2 hours before and after regular school hours)
- deployment of 3,000 **HEPA air scrubbers, and
- additional air conditioning being installed in 15 schools in 2022

*MERV: Minimum Efficiency Reporting Values | **HEPA: High Efficiency Particulate Air [filter]

Fortunately, after this temporary rise in energy consumption, DPCDSB is now again back on track to conserve energy, as demonstrated by a 6% reduction in 2023.

Facilities Renewal Plan 2024 – DPCDSB has finalized our 2024 Facilities Renewal Plan. As a result of rising labour and materials costs, along with ongoing supply chain sourcing issues, a narrow timeline for conducting major renewal and maintenance work and expectations from the Ministry of Education for the timely completion of renewal projects, DPCDSB is taking a more targeted approach in 2024 to focus on priority renewal needs. While the majority of the work is scheduled to take place over the upcoming summer months, some work will occur in the evenings/weekends in the fall due to the number of projects being undertaken. As supply chain issues continue to affect the construction industry, it is possible that some projects may be deferred until 2025.

A summary of the 2024 major renewal, maintenance projects and facility upgrades in the Mississauga North Family of Schools is provided below. Other smaller projects may be undertaken in 2024 through operational funding and are not shown on this list. As is our practice for all facility renewal projects, letters will be distributed to the respective school communities, identifying the scope of work and projected timelines.

- Our Lady of Mount Carmel Catholic Secondary School - Replace air handling units and add air conditioning (A/C) to gymnasium, field restoration (track and pit) and partial roof replacement
- St. Aloysius Gonzaga Catholic Secondary School - Heat pump and heat recovery units
- St. Bernard of Clairvaux Catholic Elementary School - Playground
- St. Joan of Arc Catholic Secondary School – Building automation system (BAS)
- St. John of the Cross Catholic Elementary School - BAS
- St. Simon Stock Catholic Elementary School - Boiler replacement

Update to Permit Rates – Over the last several years, DPCDSB staff has been working to ensure that the use of Board facilities by community groups and organizations is based on a minimum of actual cost recovery. The last increase to DPCDSB’s permit rates was in the 2019-2020 school year. At that time, the increase in rates reflected actual operating costs. However, for the last five years and throughout the COVID-19 pandemic, rates have remained unchanged despite significant operational cost increases. As a result, DPCDSB is not currently recovering all of the costs associated with providing space to permit user groups. Staff from DPCDSB and the Peel District School Board (PDSB) have been working collaboratively to establish new permit rates for community user groups, effective September 1, 2024. Our board will gradually move towards a full cost recovery model to ensure alignment and consistency between the two school boards. Both the DPCDSB and PDSB are committed to an ongoing review and adjustment of permit rates annually or as required.

Emergency Instructors – DPCDSB makes every effort to ensure that when educators are absent, they are replaced with a certified teacher in the classroom. However, when we are unable to do so, in accordance with the Education Act, the board does utilize emergency instructors to ensure student safety.

National Family and Life Week 2024 – DPCDSB affirms the sacred character of human life and we are called to serve and to love one another. Respect for life means that all human beings have value and deserve to be treated with dignity and respect from the eldest to the youngest; from those who are strong and healthy to those who are vulnerable because of illness or disabilities; and from those who can speak for themselves to those who cannot. As a Catholic community of faith, we will celebrate this call as we work together to nurture and empower our students and one another to stand up for those who are most vulnerable.

During this week, the DPCDSB will invite staff and students to celebrate the sacred character of human life as lived out in family life through the various resources provided by the CCCB’s Office for Family and Life. Resources will be made available prior to that week enabling schools to prepare.

Community Clean up – The Lisgar Residents’ Association (LRA) in Ward 10 Mississauga, has organized a 3rd Annual Community Park Clean Up on Saturday May 11, from 10:00 am – 12:00 pm. This year’s event will start at various locations and finish at the basketball courts near Lisgar Middle School. This is a great opportunity for families to contribute to taking care of our community. DPCDSB secondary students can also earn volunteer hours towards fulfilling their graduation requirement of community service.
