6. Previous Business: C. Kyte

Superintendent Papaloni introduced C. Kyte, General Manager, Clinical Services, to update the committee on discussions with ErinoakKids regarding School Based Rehabilitation Services. ErinoakKids is working on improvements to their website with respect to gathering parent feedback. SEAC requested data from ErinoakKids regarding waiting lists, service volumes, and the primary areas of need that are being addressed by the services. Staff will continue consultation with ErinoakKids to determine what data is available and how parents can best provide feedback about services.

B. Presentations and Staff Reports

1. Speech and Hearing Month: J. Dean

Superintendent Papaloni introduced J. Dean, Chief, Speech, Language, Hearing and Vision, to present information on Speech and Hearing Month. J. Dean discussed resources provided by the speech, language, hearing and vision services. The month of May is Speech and Hearing month, acknowledging the wonderful work provided by Speech Language pathologists and Teachers of the Deaf and Hard of Hearing.

2. Special Education Plan 2024-2025 Review: L. Pincente

Superintendent Papaloni introduced L. Pincente, Coordinator, Special Education. L. Pincente discussed the Special Education Plan, reviewing updates in the plan for 2024-2025, including the new program names, the transition navigator role and staff development. After the presentation, training for staff was discussed.

3. Employment Supports Fair: L. Pincente

L. Pincente presented the next Parent Reaching Out Grant Event, Employment Supports Fair, taking place on Wednesday, May 28th at St. Marcellinus CSS. This event supports students with an IEP to facilitate finding employment through agency resources.

4. Crisis in the Classroom: Superintendent Papaloni

Trustee Bruno Iannicca introduced Superintendent Papaloni to discuss the article Crisis in the Classroom, from Community Living in partnership with the University of Ottawa. Superintendent Papaloni reviewed the report, noting the very small sampling, less than 1% of the Special Education student population. The sampling was taken from remote locations with limited diversity. Many of the recommendations given are already in place in Dufferin-Peel. Staff at Dufferin-Peel receive regular training. After the presentation, hiring practices were discussed, noting that Dufferin-Peel posts Special Education positions every year to ensure that teachers are choosing those positions actively.

D. Reports from Trustees for Receipt

Trustee Luz del Rosario mentioned celebrations for Catholic Education Week. Trustee Bruno added that the Special Education students participated in this event, and the plays they put on were amazing. Trustee Luz del Rosario discussed the Puratos baking school which will be implemented into Dufferin-Peel's curriculum for students, including Special Education students. She also mentioned Project SEARCH, an opportunity for Special Education students to participate in job training to transition from high school. Trustee Bruno Iannicca mentioned that he will be attending a prom on May 30th for children who learn differently. He discussed ongoing issues such as LTD, as well as loss of subsidies from lower student numbers.

C. Koczmar, Community Living, mentioned the Tim Hortons Smile Campaign.
