BACKGROUND

The *Education Act* and the Dufferin-Peel Catholic District School Board (DPCDSB) require periodic review and maintenance of policies. This process includes consultation with various internal and external community stakeholders. Additionally, policies and organizational structures must promote the goals set out in the Multi-Year Strategic Plan (MYSP) and encourage pupils to pursue their educational goals. As a result of the review cycle and Ministry of Education requirements, DPCDSB Staff have conducted an extensive analysis of policies that require review and/or development. This report was created to identify those policies up for review during 2025-2026.
