 - 1. Renaming of St. Ruth Catholic Elementary School

Superintendent Odo summarized the report.

- Trustee Darryl D'Souza proposed retaining St. Ruth Catholic Elementary School for the
 current academic year and surveying the community later this year with the two names
 selected by the area trustee as per DPCDSB policy. The two names are: St. Joseph Vaz
 and St. Elizabeth who is the Mother of John the Baptist CES. The renaming to occur in
 September 2026.
- 2. Chair Luz del Rosario temporarily passed the chair to Vice-Chair Thomas and sought clarification on the proposal for a third survey.
 - Trustee D'Souza clarified that the survey need not be immediate and suggested communicating to the community that the renaming will occur in September 2026, citing concerns about optics under supervision.
- 3. Trustee Paula Dametto-Giovannozzi commented that the community has been surveyed twice, the first outcome was St. Ruth CES in April, the following survey conducted at the

- request of the Archdiocese resulted in St. Carlos Acutis CES. She recommended excluding *St. Joseph Vaz CES* from future surveys.
- 4. Trustee Bruno lannicca expressed concern about conducting a third survey, noting 63% community support for *St. Carlos Acutis CES*.
- 5. Trustee Stefano Pascucci inquired whether the community questioned the second survey.
 - Director Mazzorato confirmed only one inquiry was received.
- 6. Trustee Stefano recommended adopting the community's preferred name, *St. Carlos Acutis CES*.
- 7. Trustee Mario Pascucci asked about next steps.
 - Director Mazzorato confirmed communication will be sent to the school community regarding the renaming. The current lettering of the school name is not permanent, the permanent lettering of St. Carlos Acutis CES will be finalized and changes will be made to the boulevard sign.
- 8. Chair Luz del Rosario again passed the chair to Vice-Chair Thomas and asked if trustees would be invited to the school blessing.
 - Director Mazzorato will follow up.
- 9. Trustee Bruno lannicca requested clarification on trustee attendance at denominational events, including school anniversaries and blessings.
- 10. Trustee Mario Pascucci emphasized the importance of trustee participation in such events.
